RESOLUTION NO. 3824

A RESOLUTION TO COMPILE ORDINANCES AS A SUPPLEMENT
TO THE CODE OF ORDINANCES OF THE CITY OF WAUKON, IOWA, 1998

WHEREAS, subsequent to the adoption of the Code of Ordinances of the City of Waukon, Iowa, 1998, the Council has adopted Ordinances Number 811 through 812, as amendments to the Code; and

WHEREAS, Section 380.8 of the Code of Iowa authorizes cities to compile new ordinances and amendments as a supplement to the Code of Ordinances and to adopt the supplement by resolution;

THEREFORE, BE IT RESOLVED by the Council of the City of Waukon, Iowa, as follows:

Section 1. Ordinances Number 811 through 812 previously adopted by the City Council of the City of Waukon are hereby compiled as a supplement to the Code of Ordinances of the City of Waukon, Iowa, 1998.

Section 2. The supplement referred to in Section 1 is hereby adopted, and, pursuant to Section 380.8 of the Code of Iowa, hereby made a part of the Code of Ordinances of the City of Waukon, Iowa, 1998.

Section 3. All resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed to the extent of such conflict.
